

# **BASSINGBOURN-CUM-KNEESWORTH PARISH COUNCIL**

## **EMAIL AND INTERNET POLICY**

### **1. INTRODUCTION**

- 1.1.** The Council recognizes that email and internet are important information and communication systems which are used during the course of Council business. This policy provides guidelines and procedures to protect users and the Council.
- 1.2.** This policy applies to all employees who have access to the internet and email facilities via Council computers.
- 1.3.** The email policy applies to all Councillors in their correspondence in an official capacity including that with employees and/or other Councillors.

### **2. EMAIL**

- 2.1.** Use of email is encouraged as it provides an efficient system of communication. Email should be regarded as written paper documents for the purposes of production, use, retention and disclosure and can be called upon under the Freedom of Information Act 2000. Personal information should be kept in accordance with the Council's policy under the General Data Protection Regulations.
- 2.2.** A Parish Council email address is expressly for the purpose of supporting the Council's official activities
  - 2.2.1.** Under no circumstances should the service be used to operate or support a business or private venture.
  - 2.2.2.** Under no circumstances should the service be used for any purpose that may be considered illegal or mischievous.
- 2.3.** Email sent from a Parish Council email address shall include an authorised disclaimer.
- 2.4.** The Council reserves the right to open any email file stored on the Council's computer system.
- 2.5.** The following guidelines for email use should be observed by all employees and Councillors:
  - 2.5.1.** Use appropriate language to avoid unintentional misunderstandings;
  - 2.5.2.** Respect the confidentiality of information contained within emails, even if encountered inadvertently;
  - 2.5.3.** Check with the sender if there is any doubt regarding the authenticity of a message;
  - 2.5.4.** Check e-mails and attachments for viruses and malware and do not open any attachment unless certain of the authenticity of the sender;
  - 2.5.5.** Only copy emails to others where appropriate and necessary;
  - 2.5.6.** Emails which create obligations or give instructions on behalf of the Council must be sent by officers only, not Councillors;
  - 2.5.7.** Emails must comply with common codes of courtesy, decency and privacy and with the Council's policy on bullying and harassment.

### **3. INTERNET USAGE**

- 3.1.** Employees are encouraged to use the internet responsibly as part of their official and professional activities.
- 3.2.** Information obtained via the internet and published in the name of the Council must be relevant and professional. A disclaimer must be stated where personal views are expressed.
- 3.3.** The use of the internet to access and/or distribute any kind of offensive material will not be tolerated and employees may be subject to disciplinary action.
- 3.4.** The equipment, services and technology provided by the Council are the property of the Council. The Council reserves the right to monitor internet traffic and monitor and access data that is composed, sent or received through its equipment.
- 3.5.** Unacceptable use of the internet by employees includes, but is not limited to:
  - 3.5.1. sending or posting discriminatory, harassing or threatening messages or images;
  - 3.5.2. using computers to perpetrate any form of fraud, and/or software, film or music piracy;
  - 3.5.3. obtaining, using or disclosing another employee's password without authorisation;
  - 3.5.4. sharing confidential material or proprietary information outside of the Council;
  - 3.5.5. hacking into unauthorised websites;
  - 3.5.6. sending or posting information that is defamatory to the Council, its services, Councillors and/or members of the public;
  - 3.5.7. introducing malicious software onto Council computers and/or jeopardising the security of the Council's electronic communication systems;
  - 3.5.8. sending or posting chain letters, solicitations or advertisements not related to Council business or activities;
  - 3.5.9. passing off personal views as those representing the Council;
  - 3.5.10. accessing inappropriate internet sites, web pages or chat rooms.
- 3.6.** If an employee is unsure about what constitutes acceptable internet usage, then further guidance and clarification should be sought.

### **4. SECURITY**

- 4.1.** Only software purchased and/or authorized by the Council shall be installed on the Council's computer system. Software licences shall be retained.

### **5. REPORTING AND SANCTIONS**

- 5.0** If a Councillor receives an email from an employee which they believe is contrary to the guidance provided in this policy, it should be reported to the Chair who will consider use of the Council's formal disciplinary procedure.
- 5.1** If an employee receives an email from a Councillor which they believe is contrary to the guidance provided in this policy, the employee is entitled to consider use of the Council's grievance policy and/or report the issue through the procedures outlined in the Member's Code of Conduct.
