

# Bassingbourn-cum-Kneesworth Parish Council Planning Committee

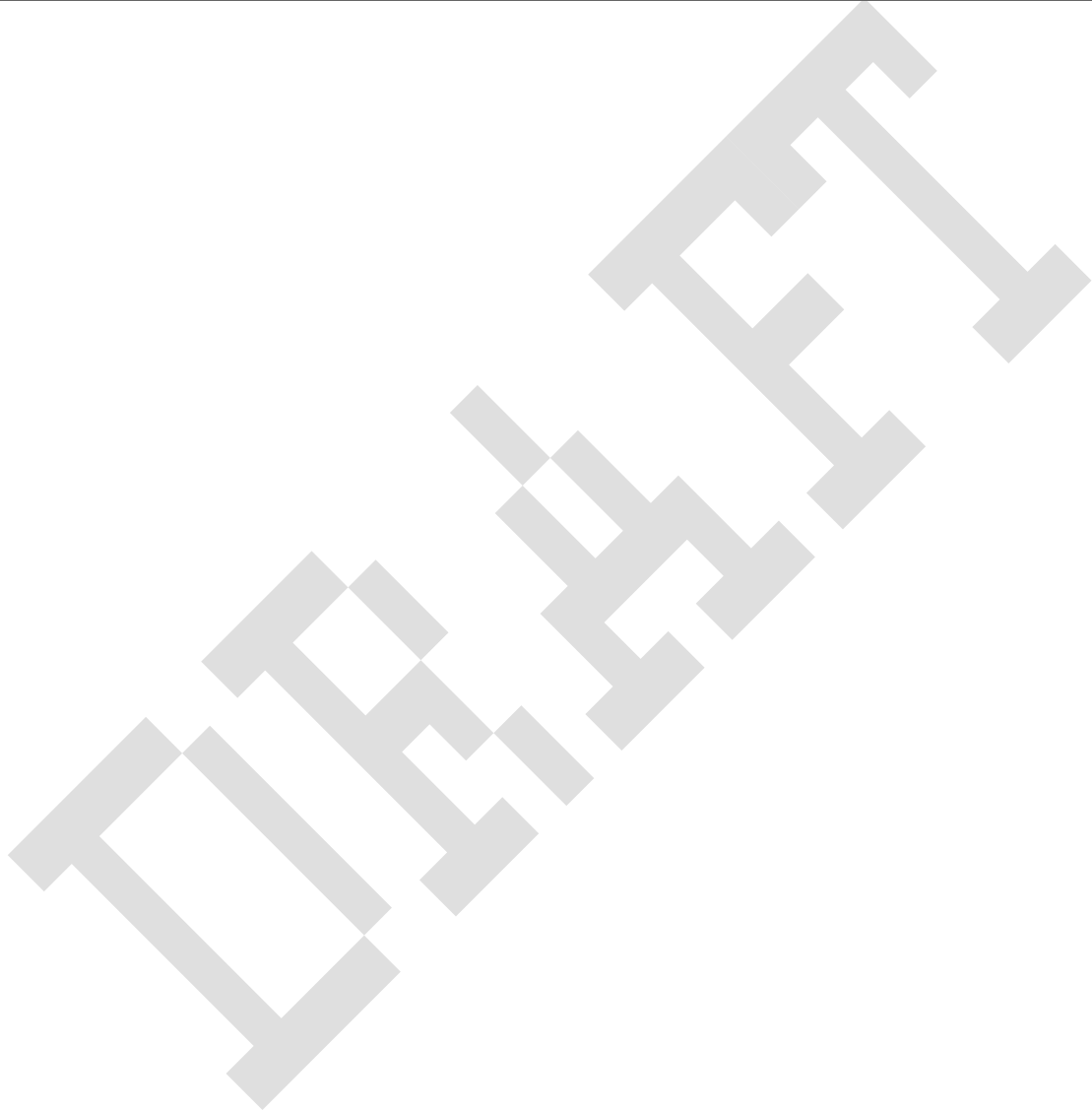
Minutes of Planning Meeting held remotely on **7th July 2020**
